## **Tuition Assistance Application**

Buena Vista, NCS, Auburn Adventist Academy

Our goal is to assist in making Christian education possible for families who need assistance and sincerely desire to have their children enrolled in a Seventh-day Adventist School. Tuition assistance is intended to help bridge the gap in financial situations where a family might otherwise be unable to send their child to Seventh-day Adventist schools. These funds are available because members specifically give to our *Student Aid Fund* and/or are included in the church budget.

We have a limited amount of financial assistance available to provide. Available tuition assistance funds are prioritized on the basis of *financial need*, *faithful parental contribution* and *student cooperation*.

North Hill Adventist Fellowship's criteria and expectations before considering tuition assistance are as follows:

- 1. The student and the student's family hold membership, and are in regular attendance at North Hill Adventist Fellowship.
- 2. The student and/or the student's family return a regular offering.
- 3. The recipient's parent or legal guardian pays the monthly financial contribution agreed upon as part of the tuition assistance program toward the recipient's tuition.
- 4. The recipient demonstrates noteworthy responsibility in areas of citizenship, attendance and study.

- 1. The student must be employed with earnings applied toward their tuition.
- 2. The student's parents are approved by Auburn Adventist Academy for the 3-Way Matching Funds.

Tuition assistance funds are budgeted based on the full year if the application is submitted prior to or during the first semester. A student's financial request will be reviewed at the end of the first semester for continued eligibility and subject to revision or change as necessary. Payments are made once per semester.

A note on church status change for 2020/2021

#### **BUENA VISTA**

In 2019, North Hill Adventist Fellowship voted to leave Buena Vista Seventh-day Adventist School's constituency. For those who have previously had students at BV there will be a change to which tuition rate is charged to members of NHAF.

Previous tuition category: BV Constituent (2020/21 rate: \$411/month)

Current tuition category: Conference Constituent (2020/21 rate: \$583/month)

This means that the rate presented to you during registration will be higher than it was previously. However, NHAF has committed to covering the difference between the BV Constituent and Conference Constituent rates. This is a commitment extended to all NHAF members who send their children to BV regardless of the need for student aid.

#### NORTHWEST CHRISTIAN SCHOOL

Due to exiting BV constituency, NHAF can offer further assistance with students wanting to attend Northwest Christian School. At NCS the rates are as follows:

Conference Constituent: 5% discount

NHAF has committed to covering the 15% difference between the rates. This is a commitment extended to all NHAF members who send their children to NCS regardless of the need for student aid.
